

Notice of Stanly County Polling Places and Buffer Zones

The following is a list of Stanly County polling places and a description of each buffer zone concerning Election Day electioneering. Buffer zones as designated by G.S. 163-166.4(a), county board of elections, shall, where practical, set the limit at 50 feet from the door of entrance to the voting place, measured when that door is closed, but in no event shall it set the limit at more than 50 feet or at less than 25 feet.

The poll workers will mark buffer zones on Election Day with “No Campaigning Beyond This Point” signs. Electioneering will be allowed as noted:

50 ft from the front entrance

50 ft from the outside entrance to the gym

008 Albemarle 8: E.E. Waddell Center, 621 Wall St Albemarle
50 ft from the front entrance to the main building

0010 Albemarle 10: W Albemarle School Board Rm., 1503 W Main St Albemarle
50 ft from the rear entrance leading to the board room

0011 Albemarle 11: Albemarle Fire Station #3, 209 NE Connector Albemarle
50 ft from the rear entrance

50 ft from the left side entrance
