**October 9th**—Voter Registration Deadline—Books Close Applications must be post-marked, faxed\*\*, emailed as scanned document, or hand delivered by this date.

**October 14th**—\*\*Deadline to receive originals of faxed registrations for new voters or party changes

**October 15th**—One-Stop Absentee Voting Begins at Stanly County Board of Elections Office

**October 27th**—Last Day to apply for Absentee By-Mail Ballots AND last day to mail out Absentee By-Mail Ballots

**October 31st**—Last Day for One-Stop Absentee Voting

**November 2nd**—5:00 pm Deadline to return ALL Ballots

**November 3rd**—General Election, Polls open from 6:30 am until 7:30 pm

## ABSENTEE BY MAIL VOTING

Any registered voter can request an absentee by mail ballot. The request must be in writing and must include the voter's printed name & address as registered, the address to which the ballot is to be mailed to, voter's date of birth and signature.

## NO EXCUSE ONE-STOP ABSENTEE VOTING
